



CALL FOR ARTISTS 2016

Thank you for your interest in the Eagle Arts Commission. We are pleased to announce the opportunity to exhibit your work during 2016. The Eagle Arts Commission shows the work of both local and regional artists in a variety of mediums including paintings, drawings and photography. We encourage you to file a submission of your work for consideration for display at galleries managed by the Eagle Arts Commission.

Eligibility

1. Artists working in 2D painting, drawing, print making, photography and mixed media are encouraged to apply.
2. The work must be framed or professionally presented if not framed. Do not submit work with scratched, warped stretchers, damaged or worn frames.
3. You **MUST** include medium, dimensions, and retail price.
4. All work must be wired properly for hanging on gallery rods.
5. All work must be original. No reproductions, posters, or giclee prints of your paintings.
6. All submissions **MUST** include an artist bio/resume and an artist's statement or description of the process of creating the work. The documents must be in a PDF and WORD document.
7. All submissions must submit on a disk or flash drive (non-returnable) clearly labeled with artists last name to the City Clerks at Eagle City Hall, 660 Civic Lane Eagle, Idaho 83616.
8. Please include your last name and title of the work in the name of the jpg file.

9. Please submit up to 6 images for consideration and only submit images of work available for showing.
10. No artwork will be displayed which cannot safely be hung or displayed utilizing the gallery's equipment; requires unusual maintenance, handling or security; or is disruptive or likely to offend the sensibilities of the general public. Each piece to be displayed will be evaluated for its compliance with these general requirements. Selectees will be asked to enter into an Artist Commitment Agreement with the City setting for specific conditions for display.
11. **Deadline for submission: 5:00 pm Thursday March 31, 2016**

Application must be submitted to City Hall on a disk or flash drive by 5:00 pm THURSDAY, MARCH 31, 2016.

- ✓ ***Up to 6 properly labeled .jpg images of your artwork on PC compatible disk or flash drive.***
- ✓ ***Non-refundable Gallery maintenance fee of \$20.00***

Notification

The Eagle Arts Commission and/or its jurors reserve the right to choose artwork deemed appropriate. Artists will be notified as early as possible after the jury convenes, either via email, letter, or phone call with the committee's decision regarding submission. Please note that although your work might meet all of the criteria at an acceptable level, the committee reserves the right to refuse work based on suitability to the atmosphere and aesthetics of the Eagle Arts Commission and available space.
