RESOLUTION No. 13-09

A RESOLUTION REPEALING RESOLUTION 13-04 IN ITS ENTIRETY, AND ADOPTING A NEW FEE SCHEDULE PURSUANT TO SECTION 7-1B-3 OF THE EAGLE CITY CODE, TO PROVIDE FOR THE ESTABLISHMENT BY RESOLUTION OF FEES FOR MECHANICAL PERMITS REFERENCED IN SECTION 106.5.2 OF THE INTERNATIONAL MECHANICAL CODE; AND PROVIDING FOR EFFECTIVE DATE.

WHEREAS, public notice for a public hearing for these fees has been published in The Valley News on April 29, 2013 and May 6, 2013 as required by Idaho Code; and

WHEREAS, a public hearing on the mechanical permit fee schedule was held on May 14, 2013; and

WHEREAS, mechanical permit fees have not been altered since 2003; and

WHEREAS, the City Council has approved amending and updating the City's fee for mechanical permits by this resolution;

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF EAGLE, IDAHO:

Section 1: That said mechanical permit fees shall be as follows:

NEW HOMES	
< = 1500 sq. ft.	→ \$130.00
1501 to 2500 sq. ft.	→ \$195.00
2501 to 3500 sq. ft.	→ \$260.00
3501 to 4500 sq. ft.	→ \$325.00
> 4500 sq. ft.	→ \$325.00 plus \$65.00 per additional 1000 sq. ft.
EXISTING RESIDENTIAL: <i>includes Retro Fits, Additions, etc.</i>	
BASE FEE: → \$50.00 plus \$10.00 per HVAC item	
SUPPLEMENTAL PERMIT: → Base Fee \$10.00 plus \$10.00 per HVAC item	
OTHER INSPECTIONS AND FEES:	
1. Inspections outside the normal business hours, per hour (minimum charge – 2 hours)	→ \$50.00
2. Reinsertion fee assessed per inspection	→ \$50.00
3. Additional plan review required by changes, additions or revisions to plan or to plans for which an initial review has been completed, per hour (minimum charge ½ hour)	→ \$50.00
COMMERCIAL FEE SCHEDULE: <i>[does not include Base Fee]</i>	
Under \$500,000	→ Base fee plus 2.07% of job value
\$500,000 to \$1,000,000	→ \$10,350.00 plus 1.55% of job value over \$500,000
Over \$1,000,000	→ \$18,112.50 plus 1.03% of job value over \$1,000,000

Section 2: That the Mayor and City Council are hereby authorized to execute said schedule for and on behalf of the City of Eagle;

Section 3: That this Resolution shall be in full force on June 1, 2013.
