



## ***“Eagle Arts Commission Winter Quilt and Decorative Fiber Art Exhibit”***

**EXHIBIT DESCRIPTION:** “Eagle Arts Commission Winter Quilt and Decorative Fiber Art Exhibit” is an open exhibition coordinated by the City of Eagle Arts Commission (EAC) and the Boise Basin Quilters’ Guild. All works deemed acceptable will be exhibited at the Eagle Senior Center at 312 East State Street, Eagle, Idaho 83616 on **December 5, 2020 from noon to 5:00 pm.**

**ELIGIBILITY:** All entries must be original and may be of winter theme or general theme. Adults and youth are welcome to enter.

**VIEWERS CHOICE AWARDS:** There will be Viewer’s Choice ribbons and monetary awards presented.

### **ENTRY REQUIREMENTS:**

1. The registration process will require artists to submit their completed entry form and two (2) 4” x 6” color photos of the top/front of the entry that will be shown. The entry form can be found at the bottom of this document. Entries may be emailed to [ArtsCommission@cityofeagle.org](mailto:ArtsCommission@cityofeagle.org) or hand delivered (during regular business hours) or mailed to 660 East Civic Lane, Eagle, Idaho 83616. There is no entry fee.
2. **Display space permitting, the first sixty (60) entries will be accepted.** Additional entries will be accepted, based on space availability. Artists will be notified of their acceptance per the date noted below. Only one entry eligible for voting will be allowed per artist; additional entries may be accepted for display only, space permitting. See No. 4 below regarding rejection of any submission.
3. **Entries shall be no larger than 72” on a side.** Vintage, new, modern, traditional, handmade, both machine and handwork, and decorative art fiber entries are accepted. There is no time limit as to when the fiber work was created, but the entries must not have been displayed in the EAC Winter Quilt and Decorative Fiber Art Exhibit in previous years.
4. All entries must be in clean and excellent condition. They must be free of all stains, pet hairs, lint and odors. When evidence of pet hair, lint or odors is identified, the work will be isolated and returned to the entrant without being shown. The EAC reserves the right to reject any submission it deems inappropriate or does not comply with the entry requirements.

### **TIMELINE:**

1. **Wednesday, October 14, 2020: Registration begins.** E-mail, drop off or mail the completed entry form, two 4” x 6” color photos of the fiber work and an artist’s statement.
2. **Sunday, November 22, 2020: Registration Ends.** Last day to submit completed entry forms.
3. **Monday, November 23, 2020: Entrants will be notified of acceptance into the exhibit via phone call or e-mail.**
4. **Monday, November 30, 2020:** Entries will be accepted between **10:00 am - 4:00 pm.** to *Eagle City Hall, 660 East Civic Lane, Idaho.* Any artwork submitted before, or after, those hours will not be accepted. Please be sure to attach your entry label and present your claim check at drop off.
5. **Saturday, December 5, 2020:** The exhibit opens and is available for viewing noon – 5:00 pm. Entries may be picked up, with receipt, 5:30 pm - 6:00 pm.
6. **Monday, December 7, 2020, 8:00 am – 4:00 pm:** Entry pick-up. The person picking up the artwork must present the claim check identifying the entry. If you do not have your claim check receipt, you must wait until all other entries have been picked up before your request will be processed and your entry returned to you.


