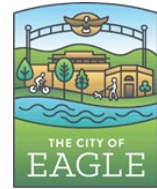




**EAGLE ARTS COMMISSION**  
**“ART STOP PROGRAM”**  
**CALL FOR LITERARY ARTISTS**



**OVERVIEW**

The Eagle Arts Commission (EAC) is pleased to provide **literary artists** the opportunity to submit their work for the “*Art Stop*” literary public art program on Eagle’s public trails and pathways. The intent of the program is to add to the City’s collection of public art with examples of literary art, whether spoken or sung, that are intended to be contextually specific to a designated place within the City’s trails and pathways system. The public will access this literary art via a QR Code on an *Art Stop* sign at each designated location, and will listen to the works of literary art via the City’s smartphone app in the same location that the works were created or inspired.

**THE ART STOP**

The *Art Stop* in question for this call is the **North Channel Bridge** pictured below.



**EXAMPLES & INSPIRATIONS**

Artists are to use this specific location to find inspiration that expresses itself in a literary work with an emphasis on the natural surroundings and sense of specific place. It could be prose that encourages the listener to journey across the bridge and farther down the path along with the story. It could be a poem inspired by the transition point. It could be a song written while standing on the bench and reflecting on the calls of native birds and the lapping of the water. It could be a fictional recounting of events bringing someone to cross this bench. Given the nature of literary work, it is somewhat uncomfortable to provide or suggest these overly literal examples; the only true parameter is that what is created is original literary work inspired in some way by the specific place, giving the listener the opportunity to connect with the work by listening to it in the same place.

## **FORMAT**

Artists are to record a reading or singing of their work in an mp3 format for delivery to the City along with a .pdf or .docx document. The final recording of the audio for the program may be commissioned separately by the EAC to be read by additional artists.

## **DURATION & OWNERSHIP**

The artist will hold the copyright to their work, and the City will be granted non-exclusive rights to display the work in any and all electronic forms in perpetuity. Over time, the City may install more than one work of art in any location, and may remove work at any time temporarily or permanently at their sole discretion.

## **SUBMISSION GUIDELINES AND COMPENSATION**

1. Artists are encouraged to submit original work for consideration, including a cover letter describing their inspiration and the circumstances under which the work was conceived of and created, and a resume of previously published literary work.
2. Chosen artists will be paid **\$500.00** each for the non-exclusive rights to display the work in any and all physical, published and electronic forms in perpetuity.
3. Submittals shall be completed online at [artscommission@cityofeagle.org](mailto:artscommission@cityofeagle.org) by **5:00 p.m. (MST) Friday, January 14th, 2022.**
4. Late submittals will not be accepted.
